POST GRADUATE DIPLOMA

- A post –graduate professional Diploma in Behavioural Science (Dip.B.Sc)
- Awarded by the CREDO Trust (a not-for-profit charitable Foundation and Trust)
- 6 – 12 months (only required for those without Bachelors Degree).
- Cost: UK Pounds 1481/ US Dollars 2350/ RM 8,000

MASTERS DEGREE (M.Sc)

- A professional Masters of Science in Behavioural Science
- Awarded by Isles Internationale Université (IIU) recognized by the European Union, the UK government, and the Oxford Association Of Management (OXIM, UK).
- 12 – 18 months
- Cost: UK Pounds 2963 / US Dollars 7050/RM16,000

DOCTORAL DEGREE (Ph.D)

- A professional Doctor of Philosophy Degree
- Awarded by Isles Internationale Université (IIU) recognized by the European Union, the UK government and Oxford Association Of Management (OXIM, UK)
- Entitled to Professional Membership of Oxford Association of Management (OXIM,UK)
- 12 to 24 months
- Cost: UK Pounds 4450/ US Dollars 8537/RM24,000.00

Methodology

- Comprises 6 compulsory and two elective units selected from a list of 24 given subjects
- Each assignment to be between 2000 & 3000 words
- An annotated bibliography of 25 abstracts, each of approximately 150 words in your specialist area
- Students are expected to read extensively on each of the topic areas, referencing research articles, books, journals, internet web sites, etc

- Comprises 12 topic assignments, selected from a list of 24 given subject areas (before exemptions)
- 8 topics are compulsory and 4 elective choices
- Assignments to be between 2000 to 3000 words
- An annotated bibliography of 50 abstracts, each of 150 words in your specialist area
- Students are expected to read extensively on each of the 12 topic areas, referencing research articles, books, journals, internet web sites, etc

- Completing a Research Proposal of 2000 words after completing a Research Methods assignment.
- There will be an 'online' interview via Skype or other means, to provide guidance (if needed)
- The topic of Research should focus on a hypothesis developed for research purposes and should be in areas related to behavioural science, with practical of professional applications
- A research report of 30 to 40 thousand words must be completed and submitted for a viva.

Exemptions of up to 50% for Approved Prior Experiential Learning (APEL)

- A written port folio of the students life and work, documenting continuous learning from this, can qualify for exemptions up to 30% credit units.
- For related materials, books or manuals written or produced by the student, if approved, can qualify for a further exemptions of 20% credit units.

Assessment

- Based on the satisfactory completion of the 8 topic assignments.
- Satisfactory completion of the 25 abstracts
- Demonstrated evidence of new and personal learning from own studies/experience
- From your studies, one article of 2000 to 3000 words must be submitted for the IIU journal

- Based on the satisfactory completion of the 12 topic assignments.
- Satisfactory completion of the 50 abstracts
- Demonstrated evidence of new and personal learning from own studies/experience
- From your studies, two articles between 2000 to 3000 words must be submitted for the IIU's journal

- Based on the completed project report (including the Research Proposal)
- A viva (an interview with questions on the project report) Would be conducted. This can be face to face or by telephone interview
- From your studies, two articles between 2000 to 3000 words must be submitted for the IIU's journal
